In 2002, Ms. DiCamillo formed D+G Consulting Group, LLC, an aviation strategic

Ms. DiCamillo has successfully represented many airport clients with airline negotiations, rates and charges issues, plans of finance, feasibility studies, bond issuances, rating agency presentations, gate usage procedures, development of consolidated rental car facilities, and negotiation of rental car agreements. Ms. DiCamillo has been the project manager on assignments such as airline negotiations at Cincinnati, Dallas Ft. Worth, Glacier Park (MO), Indianapolis, and Jacksonville; consolidated rental car facility negotiations at Chicago O'Hare and Memphis; fueling agreement negotiations at Dallas Ft. Ms. DiCamillo has participated as financial advisor, in the issuance of over \$8.5 billion of airport bonds since 2009, including GARBs, PFC bonds, LOI supported bonds, and CFC bonds.
